Common things to keep an eye on as we move through Winter into Spring

- Wellington Farm HOA has a policy against above ground pools. Please refer to the HOA website at WWW.WELLINGTONFARM.ORG
 to review policy guidelines. All pools installed not meeting the pool guidelines will be asked to be removed and enforced by WFHOA's
 Legal council at homeowners expense if necessary.
- Please keep in mind that St Charles County has code enforcement restrictions for pets in relation to their leash law. All domestic pets including feline and K-9 must be on a leash at all times unless they are fully contained within the property. Please also keep in mind that WFHOA, per indentures, retains the right to revoke a homeowners privilege to have pets at their residence should the board feel this is a necessary avenue due to homeowners negligence and/or aggressive animals.
- Please feel free to report road issues/ potholes, repaving requests to St. Charles County. We continue to report issues and requests for
 complete repaving of the road, however it appears that they are possibly assigned by the county based on the volume of complaints so
 we desperately need your help in submitting them in order for action to be taken.
- As our neighbors and kiddos start to get more active outside please be mindful to keep sidewalks unobstructed by vehicles, watch carefully for kiddos in the street (drive cautiously) and please be sure to pick up and dispose of your pets waste.
- Please let your kiddos know that the inlets at the lakes are not made for them to play around. The rocks are placed there specifically for Lake erosion purposes.
